Preferred Photographer **PROGRAM**

FOR BROKERS

Q: If I use a photographer from the Preferred Photographer Program (PPP), do I have the right to use the photographs in advertising with in the real estate industry?

A: YES. All members of the Preferred Photographer Program (PPP) sign an agreement giving the broker all rights necessary to transfer or license the copyrights/intellectual property of the images to MLS or anyone else to whom the broker may so transfer or license.

Q: Am I protected from copyright infringement if reproduced, displayed, printing, broadcasting, and licensing the images?

A: YES. The photographer grants to MLS and Broker a non-exclusive worldwide, royalty free, Unlimited perpetual license.

Q: Can the Preferred Photographer upload photos to listings on my behalf?

A: YES. All members of the Preferred Photographer Program (PPP) completed a training course for uploading photos to listings via Flex MLS.

Q: Is the photographer allowed to make any changes to the listing other than upload photos?

A: NO. The photographers are assigned a user number for the sole purpose to upload photos to a specific listing in the MLS database.

Q: My photographer is not currently part of the Preferred Photographer Program, can they be added?

A: YES. Simply refer them to our website: **www.MetroMLS.com** Look for the Preferred Photographer Program page &

submit an application.

FOR PHOTOGRAPHERS

Q: How do I become a member of the Preferred Photographer Program?

A: Submit an application. We will review the application and if you and/or the studio are a good fit, you will be invited to join.

Q: What are the requirements beyond the application?

A: Once properly vetted, you will be asked to sign an agreement between Metro MLS and Photographer/Studio. Next, you will be required to take training course for uploading photos into the MLS database. Lastly, you will be added to the list once these items are completed.

Q: What are the benefits to becoming a Preferred Photographer.

A: You'll get connected. More than 8,000 real estate professionals will have access to our Preferred Photographer Program list. Building a professional relationship of loyalty and trust benefits both the Broker and the Photographer.

Unless there is a written agreement signed by Broker and Photographer to the contrary, the Photographer hereby agrees and confirms that the Images were created under a work for hire agreement between the Photographer and the Broker and that the Broker has all rights necessary to transfer or license the copyrights in the Images to MLS or anyone else to whom Broker may so transfer or license. The parties agree that MLS and Broker are under no obligation to credit Photographer or any other third party as the author or owner of the Images.				
2.	2. To the extent that Photographer may have any Copyright rights to the Images or in the event that Photographer had a written agreement with Broker which provided that Photographer retained any copyright rights in the Images, Photographer hereby grants to MLS and to Broker a non-exclusive worldwide royalty-free unlimited license in perpetuity to reproduce, distribute, display, prepare derivate works of, and publicly perform the Images in connection with the real estate industry or any industry related thereto, including without limitation such uses of the Images in connection with advertising real property and/or business of the Broker and to authorize and sublicense such rights to third parties at Brokerage's discretion.				
3.	3. For those situations in which Photographer's work was a work for hire, MLS agrees to assign Photographer a user number to allow Photographer to directly upload to a specific listing in the MLS database those Images taken by Photographer. Photographer agrees not to use the user number for any other purpose or use.				
4.	4. The validity, construction and enforceability of this Agreement shall be governed in all respects by the laws of the State of Wisconsin. The terms and conditions set forth herein shall supersede all prior agreements and addendums. In the event of a conflict between the terms and conditions of this Agreement any other addendum or agreement, this agreement shall control. This Agreement may not be amended except in writing signed by the respective parties. The failure of either party to enforce its rights under this Agreement at any time for any period shall not be construed as a waiver of such rights
